CONTRACT AGREEMENT
No. C-2024-12-0331

THIS AGREEMENT, made this 27 day of 12-12-2024 between Department of Agrarian Reform (hereinafter called the "Entity") and **Geographic Innovations for Development Solutions, Inc.** Grove Avenue, Brgy. Batong Malake Los Baños Laguna (hereinafter called the "Firm").

WHEREAS, the Entity is desirous that the Firm execute the **Establishment of a Monitoring and Evaluation System for the Climate Resilient Farm Productivity Support Project (CRFPS) Project** (hereinafter called "the Works") and the Entity has accepted the bid for **Philippine Pesos Three Million Seven Hundred Fifty-Two Thousand and 00/100 (PHP 3,752,000.00)** by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Firm as hereinafter mentioned, the Firm hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Firm in all respects.
4. The Entity hereby covenants to pay the Firm in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
